### **Young Professional -**

- Individuals at least (21) years of age but not more than (35).
- Each Junior Single Member of the Club shall have the full privilege of using all of the Club facilities within the established operational rules and limitations established by Club management. Each Young Professional Member shall have the right to vote at any and all membership meetings and hold Club office.

### **Single -**

- Individuals of at least (35) years of age but no more than (61).
- Each Single Member of the Club shall have the full privilege of using all of the Club facilities within the established operational rules and limitations established by Club management. Each Single Member shall have the right to vote at any and all membership meetings and hold Club office.

### **Senior Single -**

- Individuals of at least (62) years of age.
- Each Senior Single Member of the Club shall have the full privilege of using all of the Club facilities within the established operational rules and limitations established by Club management. Each Senior Single Member shall have the right to vote at any and all membership meetings and hold Club office.

### **Youth -**

Individual under the age of (18)

- Each Youth Member of the Club shall have the full privilege of using all of the Club facilities within the established operational rules and limitations established by Club management. Must tee off after 11:00 on week-ends unless otherwise approved by Pro Shop Staff.
- Range Membership is included in Youth Membership

### **College -**

- Individual at least (18) years of age but no more than (21) currently attending college/university. Must present valid college identification.

### **Family -**

- Married Couples (with or without children) who are each at least (21) but no more than (35).
- An unmarried individual at least (21) with children under the age of (21).

### **Senior Family –**

- Married Couples (with or without children) who are each at least (62 and Over)
- Children must be;
  - o Under the age of 21
  - o Full-Time Students under the age of 25

### **Full Family-**

- o Married couples (with or without children) who are at least (35) but no more than (61).
- Children must be;
  - o Under the age of 21
  - o Full-Time Students under the age of 25

**Corporate -**

- Entitles corporation to 1 Single Membership which must be designated to specific individual.
- 20 Free plays (18 HOLES) with Cart included
- Range Pass included.

**Punch Card/Vacation Pass \$200.00 (GOLF) + \$120.00 (CART) = \$320.00**

- 20 Nine Hole plays
- Can be used for leagues, weekend play, holiday play, twilight.
- Not eligible for membership privileges.

- Children must be;
  - o Under the age of 21
  - o Full-Time Students under the age of 25
- Each SLU Family Member of the Club shall have the full privilege of using all of the Club facilities within the established operational rules and limitations established by Club management. Each SLU Family Member shall have the right to vote at any and all membership meetings and hold Club office.
